

## 12th Committee Bi-Annual Planning Meeting of the SCA

Unfortunately the above-mentioned Meeting, which was to be held on 20/11/21, to review the operation and viability of the SCA, was cancelled due to unforeseen circumstances, and was replaced by a Special Committee Meeting in lieu of the above, held on 7/12/21.

Present were the Members of the Committee (COM) and, as is normally the case, Chaired by the President Paolo Lostia.

Paul welcomed everyone thanking them for making themselves available, for this Special Committee Meeting, despite the Cancellation of the originally planned Meeting.

It was acknowledged at the outset that due to the on and off Covid-19 pandemic restrictions in place for most of the past 24 months, the SCA was only able to hold the December 2020 "Ringraziamento Fine Anno Per I Soci" and the March 2021 "Sa Die De Sa Sardigna lunches.

Unfortunately, this has caused a disconnect with Members, as we have only been able to keep in touch with them via this Newsletter.

Paul, not for the first time, went on to acknowledge with sadness the passing in 2020 of Committee Member, Christopher Baker, who participated at the 2019 Planning Meeting.

In highlighting the importance of this Special Committee Meeting Paul went on to state that we have been at the crossroads for some time, due to the ageing of our community and the lack of involvement of younger people, sadly even those from families who have made the SCA possible.

He directed his greatest thanks to the Members of the Committee and those individuals who contribute outside the Committee, namely Gino Cavallo, Paola Steri and Jennifer Curcio.


He then acknowledged the long standing financial support we receive from the RAS which enables us to continue to exist in the current form and successfully undertake Special Projects.

The Meeting's discussions mainly focused on:

- Short & Long Term Future of the SCA;
- Ability of the SCA's COM to carry out its local Statutory, RAS obligations and day to day administrative tasks;
- Proposed amendment to the "Winding Up Provisions in the 1987 "Articles Of Association";

In closing Paul emphasised that it is important that we commence planning our "Wind Down" in consultation with our Members. So that we have a Plan for when we close down. Despite the above Paul gave the assurance that in planning our "Wind Down", the COM will do everything possible so that the SCA continues to exist and remain relevant, be it in the current or in another form.

Lively discussions followed resulting in a number of outcomes which will be reported in detail at the 2022 AGM.
